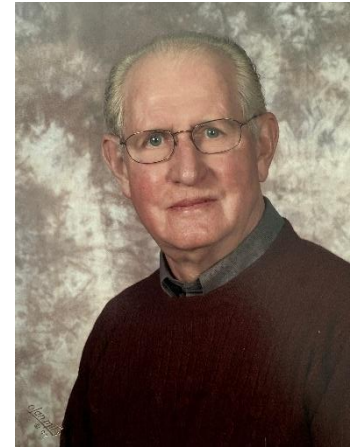


Vincent J. Kinnard

Vincent J. Kinnard, 95, New Franken, passed away peacefully on Sunday June 7, 2026. He was born on November 10, 1930, in the town of Lincoln to the late William Joseph and Lucy Mary (LeRoy) Kinnard.
